4. Evaluation of quotations

The Purchaser will evaluate and compare the quotations determined to be substantially responsive ie: which

7. Award of contract

- 1. The Purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest price.
- 2. The Purchaser, before the expiration of the quotation validity period, will notify the bidder whose quotation is accepted of the award of the contract. The terms of the accepted offer shall be incorporated in the Work order.
- 3. The contract will be valid for a period of one year, extendable by one more year, subject to satisfactory performance. The rates quoted will remain in force for the full period of the contract. No demand for revision of the rate on any account shall be entertained during the contract period.



- 4. The bidder should submit the financial bid in the format mentioned in Annexure II
- 5. Notwithstanding the above, the Purchaser reserves the right to accept or reject and to cancel the bidding process and reject all quotations at any time prior to the award of the contract, without detailing any specified reasons whatsoever.
